a nonprofit corporation, their founders, directors, officers, employees, contractors, volunteers, and agents (collectively LIVE-IT.)

The volunteer desires to work as a volunteer for LIVE-IT and engage in the activities related to being a volunteer (the "Activities"). The Volunteer understands that the Activities include but are not limited to, constructing residential buildings, working in the office, working in existing homes in the community and related activities. The Volunteer hereby, freely, voluntarily and without duress executes this Release under the following terms:

Release and Waiver. Volunteer does hereby release and forever discharge and hold harmless Live-it and its successors and assigns from any and all liability, claims, and demands of whatever kind or nature, either in law or in equity, which arise or may hereafter arise from Volunteer's Activities with Live-It.

Volunteer understands that this Release discharges Live-It from any liability or claim that the Volunteer may have against Live-It with respect to any bodily injury, personal injury, illness, death, or property damage that may result from Volunteer's activities from with Live-It, whether caused by negligence of Live-It or its officers, directors, employees, agents, contractors, volunteers or otherwise.

Insurance. Volunteer also understands that, in the event of injury incurred while engaged in Live-It Activities as a Volunteer, Volunteer's Insurance, if any, shall be totally responsible. Live-It does not assume any responsibility for or obligation to provide financial assistance or other assistance to Volunteers including, but not limited to, secondary medical, health, or disability insurance in excess of what it currently provides.

Medical Treatment. Volunteer does hereby release and forever discharge Live-It from any claim whatsoever which arises or may hereafter arise on account of any first aid, treatment, or service rendered in connection with the Volunteer's Activities with Live-It.

Assumption of the Risk. The Volunteer understands that the Activities include work that may be hazardous to the Volunteer including, but not limited to, construction, lifting, using tools, and equipment, handling and installing materials, being on the job site, loading and unloading, and transportation between work sites. Volunteer hereby expressly and specifically assumes the risk of injury or harm in the Activities and releases Live-It from all liability for injury, illness, death, or property damage resulting from Activities.

Each Volunteer is expected and encouraged to obtain his or her own medical health insurance coverage.

Photographic Release. Volunteer does hereby grant and convey unto Live-It all rights, title, and interest in any and all photographic images and video or audio recordings made by Live-It during the Volunteer's Activities with Live-It including, but not limited to, any royalties, proceeds, or other benefits derived from such photographs or recordings.

Other. Volunteer expressly agrees that this release is intended to be as broad and inclusive as permitted by the laws of the State of Tennessee, and that this Release shall be governed by and interpreted in accordance with the laws of the State of Tennessee. Any injury claims made by Volunteer against Live-It shall be filed in Sevier County. Volunteer agrees that in the event that any clause or provision of this Release shall be held to be invalid by any court of competent jurisdiction, the invalidity of such clause or provision shall not otherwise affect the remaining provisions of this Release which shall continue to be enforceable.
